Note: In order to facilitate the occupancy permit application process, the following items need to be submitted:

1. Application Form- Completely filled out and signed.
 2. Application Fee- Submitted with application- Check payable to the Township of Abington.
 3. Site Plan- If the use of the premises is a new use (i.e. vacant building) or a use different or more intense from the previous use, a property site plan will be required to evaluate parking requirements and other site issues.
 4. Layout Plan- If there is any proposed change in the existing interior tenant arrangement (i.e.
 5. Architectural Construction Plan- If any alterations are required for the new occupancy, a building permit accompanied by State Labor and Industry approved plans is required to be issued and satisfied prior to the issuance of the occupancy permit.
- A. When use is determined to be more intense than the previous use of the building, or when structural alterations are planned, the new use may require sprinklers which dictates a Sprinkler Plan and permit.

Note: Normal processing time for a full occupancy review is approximately two weeks, assuming the submission is complete.
