Odyssey of the Mind was created and founded by Dr. C. Samuel Micklus Professor Emeritus at Rowan University in 1978. It is an international program that provides problem-solving opportunities for students from kindergarten to college. Odyssey of the Mind members applies their creativity to solve problems that range from building mechanical devices and present their own interpretations of literary classes.

At the World Competition, teams from the USA, China, Canada, Germany and Japan face-off to score for their long-term problem solutions; how well they solve spontaneous problems on the spot and the style in which they elaborate their long-term solutions. The winning problem was called, "Pandora's Box."

Abington Senior High School Odyssey of the Mind Team members took part in a five-day competition held at Michigan State University and returned home as World Champions!

He introduced Odyssey of the Mind Team members Christopher Doyle, Robert Galloway, Andrew Giguere, Max Mindel, Tara Santora, Gilbert Wermeling, and Nicholas Fitzpatrick (not present) and support staff Mike Fitzpatrick, Dave Mindel and Coach Anna Mindel.

Commissioner Spiegelman said these are the young people that our schools are producing and these are the young people that our community are producing, and we could not be prouder of them.

Commissioners DiPlacido and Spiegelman presented the exceptional Abington Senior High School Odyssey of the Mind Team Members with Certificates of Commendation in recognition of their extraordinary accomplishment of winning the World Championship at the 2015 Odyssey of the Mind World Finals at Michigan State University on May 20, 2015 on behalf of the Board of the Commissioners of the Township of Abington on this 9th day of July, 2015.

ORDINANCE NO. 2097

**AN ORDINANCE ENACTING CHAPTER 126 – “REAL ESTATE REGISTRY –
VACANT PROPERTIES”**

WHEREAS, the Township of Abington is a Township of the First Class, duly organized and existing pursuant to the applicable laws of the Commonwealth of Pennsylvania; and

WHEREAS, pursuant to section 1502.44 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56544, the Board of Commissioners has the authority to enact and amend provisions of the Abington Township Code (“Code”) at any time it deems necessary for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof; and

WHEREAS, pursuant to section 1502.10 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56510, the Board of Commissioners has the authority to take all needful means for securing the safety of persons or property within the Township; and

WHEREAS, the Board of Commissioners of the Township of Abington has determined that Chapter 126 – “Real Estate Registry – Vacant Properties,” should be enacted for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof.

NOW, THEREFORE, the Board of Commissioners of the Township of Abington does hereby **ENACT** and **ORDAIN** as follows:

1. Chapter 126 – “Real Estate Registry – Vacant Properties” is hereby enacted as reflected in Exhibit “A” attached hereto.
2. All other ordinances, portions of ordinances, or any section of the Code inconsistent with


this Ordinance are hereby repealed.

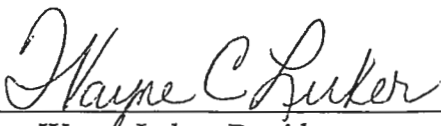
3. This Ordinance shall become effective five (5) days after enactment.

Commissioner Schreiber clarified that Mr. Lahaza’s posting on the website was not taking business away from realtors. As a courtesy, he listed vacant properties sending business to realtors.

WHEREAS, pursuant to section 1502.44 of the First Class Township Code of the Commonwealth of Pennsylvania, 53 P.S. §56544, the Board of Commissioners has the authority to enact and amend provisions of the Abington Township Code (“Code”) at any time it deems necessary for the health, safety, morals, general welfare, cleanliness, beauty, convenience and comfort of the Township and the inhabitants thereof; and

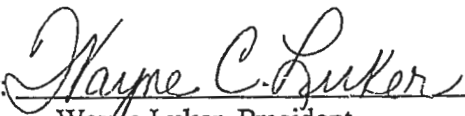

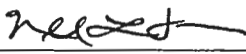

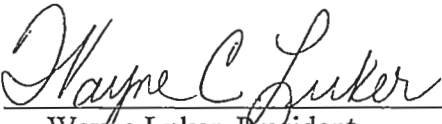

After review of proposals, staff recommends that the stormwater project on Westbury Road be removed from consideration and instead be replaced with a curbing, sidewalks and stormwater project on the 2700 block of Old Welsh Road in the amount of \$85,000; \$5,000 for lighting in Grove Park; and an additional \$10,000 for home improvements for owner-occupied.

Also, at the Public Affairs meeting last week, a request was made by reps of the Crestmont Community Center Committee for funding their project and staff is not in the position of recommending approval for those funds at this time. But staff has indicated their willingness to work with the Crestmont Community Center Committee to provide technical assistance, so they can accomplish the same goals they hope to acquire, which is a feasibility study for the project, and so they will be in the position to come before the Board for consideration in a future funding cycle.

Louise E. Twyman, 1672 Franklin Avenue, commented that she continues to get a petition signed by residents of Ward 5 in support of a community center, and she believes the Township will be able to find the money to help build one. Manager LeFevre replied that is correct. The Township does not designate which areas qualify for funding. It is determined by the Federal government.

Commissioner Kline clarified that the areas proposed for the consolidated plan meet the requirements for CDBG funding. Is that correct?

Manager LeFevre replied yes, they do.

Doug Vaughn, 1747 Easton Road, expressed his concern and disappointment in regards to this matter.

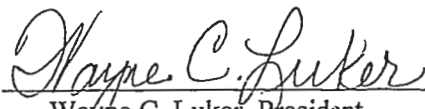

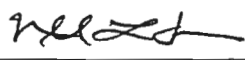
RETIREMENT BENEFITS

Commissioner Farren thanked Chief Kelly as well as a few officers who he has worked with recently regarding issues in Glenside. He reminded everyone to please lock your cars, windows and doors.

He thanked everyone who was involved with the Glenside 4th of July Parade as it was amazing.

Also, an Adult GYAC Softball League was initiated, and tonight was the first game, but he had to miss it due to the meeting. Best Wishes to Team 3 and the new GYAC Softball League.

Commissioner Gillespie thanked everyone who participated in the Greater Glenside Patriotic Association’s Parade and it was a great day. She also thanked the Abington Township Police Officers for their help as well.

Commissioner Hecker expressed his deep concern about comments made tonight as personal attacks are being wrapped up in the cloak of community betterment and that needs to stop!

There is no one sitting on this Board who is not sympathetic to the idea of a community center to benefit Township children and Township residents, and he is included.

There have been offers by Commissioner Markman and others to further the dialog and Mr. Van Strother is one of the best in this business at what he does. Commissioner Luker stands up for his constituents of Ward 5 and will continue to do so.

Commissioner Jones thanked Mr. Matteo and his staff for holding a community meeting in the rain in regards to a situation in Ward 3, and he greatly appreciated it.

He announced that on Saturday, July 18, 2015 from 9-1pm will be a Fill-A-Police-Car Food Drive sponsored by CAPT., Abington Township Police Association, Abington Township Police Department and Giant Food Store.

He thanked Mr. Micciolo and his staff for their assistance in Ward 3.

Commissioner Kline commented that he has been on this Board of eight years and he cannot ever remember thinking about discriminating between communities and he is personally offended by the comments made by some of the speakers tonight.

Also, he read a letter into the record from one of his constituents thanking Officer Wiley of the Abington Police Department for his assistance and kindness.

Commissioner Zappone thanked Manager LeFevre, Township Solicitors and Mr. Powers for their participation and assistance in the annual Tyson/ Edge Hill Update Meeting.

Commissioner Spiegelman announced that this coming Saturday will be the Township's Paper Shredding Event from 9-noon at the Highway Yard on Florey Lane, and the EAC will be holding a food drive at that event.

He thanked Commissioner Luker for his leadership on this Board and for his assistance and mentorship.
